The HGSS Assessment is in Four Parts

- MDPT Activity 1
 - Reading and responding to a general prompt with guiding questions from 2 source texts
- MDPT Activity 2
 - On-Demand writing
- HGSS Assessment Part 1
 - Historical vignettes
- HGSS Assessment Part 2
 - Interpreting Primary Source Document Excerpt



MDPT Activity 1

- Students are given a general prompt in the way of an introductory paragraph which gives students a purpose for reading
- Students are given three guiding questions they are not required to answer them and they are not scored
- Students are told the kind of writing they will be asked to do in Activity 2
- Students are given 2 document excerpts related to the general prompt to read and take notes over



MDPT Activity 2

- Students are given directions and reminders on what constitutes a strong response
- Students are given the prompt type
- Students are given the specific prompt
- Students may use all of their notes from the earlier session, answers to the guiding questions, and any student generated writing aids.



Machine Scorable HGSS Assessment





Part I: Historical Vignettes

This part of the assessment would provide content by way of historical vignettes asking a single enhanced and/or enabled multiple choice items based on a particular standard and benchmark. These questions will be designed to measure the student's ability to use content in particular ways. The items would be matrixed across the classroom to insure the assessment of all standards and benchmarks 1-3. This is required so that we can demonstrate all standards are being assessed. (8 - 10 items)



Part II: Document Analysis

- Students are given a single document excerpt
- Students are asked to read and respond to three multiple choice or technology enhanced items
- Question 1 is about the author, audience, or purpose of the document
- Question 2 is about the context (what was going on at the time)
- Question 3 is about the main idea the author expresses in the excerpt
