- What is KIDS?
  - KIDS is protected via a secure login system called Common Authentication
  - A username and password will allow you to login to KIDS
  - Each district decides how the data upload process is structured
    - One central KIDS Coordinator uploads files to KIDS
    - Each building has a KIDS Coordinator that uploads files to KIDS



- Why are data submitted to KSDE via KIDS?
  - For state reporting
  - For federal reporting
  - For accreditation and accountability





- What do I need to know about KIDS as a Test Coordinator?
  - Find out how your district structures the process
  - Find out who at your building/district submits data for your building/district



- How do schools/districts submit data to KIDS?
  - Access the student information system (SIS)
  - Generate SIS Report
  - Extract file from SIS
  - Log in to KIDS
  - Upload file to KIDS (no direct data entry is done in KIDS)



- What KIDS records are needed so that my students can take assessments in KITE?
  - It depends on what type of assessment they will be taking, so reference the State Assessments and KIDS Data 2015-2016

ASGT	Obtain SSIDs, update core student data, and claim students	Any time
ENRL	Funding and Enrollment: populate PBR and SO66	9/21/15-10/12/15
TEST	State Assessments: populate CETE website, populates Measurable Objectives, KWIET, etc.	8/17/15-6/15/16
SMSC	REAP Funding	12/01/15-1/08/16
EOYA	End of Year Accountability: populates Measurable Objectives, state and federal counts	5/16/16-6/30/16
STCO	Student Course: Course-Educator-Student link for	11/2/2015 – 8/12/2016 (2015-2016 Data)
TASC	Teacher and Student Connection: populates K-FIT, Success in School, etc.	Any time
EXIT	Students leaving school, date, reason, and any post-graduation plans	As soon as possible
QERY	Retrieve existing KIDS data about students without claiming them or changing the data	Any time

# D2: Accountability School

- All records
- School of Accountability

# D15: Funding School

- All records
- School where enrollment is counted for funding

#### D16: Attendance School

- All records
- Student attends class
- TEST: Student takes state assessments

#### F16: Educator School Identifier

- STCO and TASC
- Building where teacher teaches the course as assigned in EDCS









#### **Data Elements**

### Accountability School (D2)

- KIDS Collections: All
- Building number of the school in which the student is included for accountability
- Changing the Accountability School in KIDS will claim the student
- 0001 for students educated in assessed content areas out-of-state
- 0002 for homeschooled students or students attending unaccredited private schools or homeschooled students




#### **Data Elements**

# Attendance School (D16)

- KIDS Collections: All
- This is the school where the student is physically located and attends class.
- TEST records: the location where the student takes state assessments.
